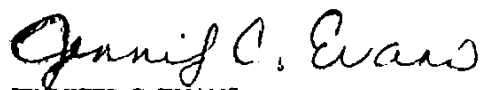
I AM WRITING IN REFERENCE TO THE 1997 PROFIT CORPORATION ANNUAL REPORT

FLORIDA EQUINE PUBLICATIONS, INC.

AMERICAN EQUINE PUBLISHERS, INC.  
WIRE TO WIRE RACING DIGEST, INC.

I WOULD LIKE TO REQUEST A WAIVE OF THE \$385.00 LATE FEE FOR EACH OF THE ABOVE  
CORPORATIONS. FLORIDA THOROUGHBRED BREEDERS AND OWNERS ASSOCIATION  
ACQUIRED THE FLORIDA HORSE, INC. AND WIRE TO WIRE RACING DIGEST, INC. IN  
AUGUST OF 1996. DUE TO THIS ACQUISITION THE COMPANIES WERE BEING CHANGED  
OVER FROM A MANUAL ACCOUNTING SYSTEM TO A COMPUTERIZED ACCOUNTING  
SYSTEM. THE ACCOUNTANT WHO WORKED FOR THE COMPANIES BEFORE THE  
ACQUISITION TOOK PLACE MADE THE DECISION TO LEAVE IN FEBRUARY BEFORE THIS  
PROCESS COULD BE IMPLEMENTED. A REPLACEMENT WAS HIRED IN MARCH AND  
STARTED THE PROCESS OF CHANGING SYSTEMS WHEN SHE HAD A STROKE ON THE JOB  
ON APRIL 1, 1997. I WAS HIRED ON MAY 5, 1997 AND HAVE BEEN WORKING DILIGENTLY  
ON MAKING THE CHANGE OF ACCOUNTING SYSTEMS COMPLETE. I HAVE ACHIEVED THE  
MAJORITY OF THE PROCEDURE AND I WAS IN THE PROCESS OF CLEANING UP THE LOOSE  
ENDS WHEN I RECEIVED THESE REPORTS ON MONDAY, JULY 21, 1997. THIS IS THE FIRST  
TIME I HAVE SEEN THESE REPORTS AS THE FIRST NOTICE WAS NEVER RECEIVED BY THIS  
OFFICE.
