ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF IGNITE FUELING INNOVATION, INC.

Pursuant to the Alabama Business Corporation Law, Sections 10A-2-10.01, 10A-2-10.03, and 10A-2-10.06, the undersigned corporation, IGNITE FUELING INNOVATION, INC., a corporation organized and existing under the laws of the State of Alabama (hereinafter referred to as the "Corporation"), hereby submits the following:

- 1. The name of the Corporation is IGNITE FUELING INNOVATION, INC.
- 2. The Articles of Incorporation of the Corporation, as previously amended, shall be further amended as follows:

There shall be added a new Article IX as follows:

"ARTICLE IX VOTING

To the extent permitted by applicable law, any requirement imposed by the Alabama Business Corporation Law for approval by the vote of two-thirds of the shareholders of the Corporation, including but not limited to, approval of a plan of merger or share exchange for the Corporation; sale of all, or substantially all, of the assets of the corporation other than in the ordinary course of business; or adoption of a proposal for dissolution of the corporation, shall be deleted such that the vote of the holders of at least 51% of the votes entitled to be cast shall be necessary to approve such shareholder action."

- 3. This Amendment to the Articles of Incorporation of the Corporation was approved by Unanimous Written Consent of the Shareholders and the Board of Directors as of August 25th, 2019. There were 4,960,000 shares eligible to vote on the amendment.
- 4. This Amendment to the Articles of Incorporation of the Corporation was not adopted by the Board of Directors without shareholder action.

- (ii) The total number of undisputed votes cast in favor of the Amendment was 4,960,000, and the number of votes cast against the Amendment was 0.
