As you know, representatives of my office as well as the President of the above referenced corporation has been in recent contact with you, and other members of your office relating to this company's registration issue with your organization (Florida Department of State) regarding the attached copy of a March 26, 2010, letter from your office. Also, please note that the above business is a domicile State of Alabama corporation.

Ms. Beyers of your office graciously directed a member of my staff, via the internet, to the pertinent rules and regulations of your organization (Florida Department of State) through the Official Internet Site of the Florida Legislature that would hopefully exempt my client (Alabama Tank, Inc.) from the \$3,557.60 of civil penaltics and annual report filing fees as referenced within the attached March 26th letter from your office. Based on my review of these various pertinent rules and regulations, my client would not be subject to the amount due pursuant to the Section of Exemptions outlined in Section 607.1501 - Authority of Foreign Corporation to Transact Business Required; Subsection (1); Item (2) - The Following Activities, Among Others, Do Not Constitute Transacting Business Within the Meaning of Subsection (1). I have enclosed a copy of this excerpt for your review.

As has been briefly and previously discussed, my client (Alabama Tank, Inc.) manufactures metal fabricated tanks at its plant located in Atmore, Alabama. This company's only business activity within the State of Florida is, on a very limited basis. that it will occasionally deliver, and/or contract to deliver a tank to one of its limited number of Florida customers. The company owns no property (real or personal) within the State of Florida, has no Florida payroll, does not maintain a sales force within State of Florida, and does not solicit business within the State of Florida. Additionally this company, since its formation in 1983, has for twenty-seven (27) years always faithfully and promptly filed, and paid its respective sales taxes to the State of Florida on a hard copy (paper) basis without any sort of a problem. No office and/or division of your State (Florida Department of State, or the Florida Department of Revenue) have ever previously notified my client (Alabama Tank, Inc.), prior to the attached March 26th letter, that any other or additional filings or registrations were necessary. If such notice had been given by the State of Florida, there is no doubt that the management of this fine and respected business in question (Alabama Tank, Inc.) would have promptly complied. Therefore, it would appear that this company in question, according to your organization's definition, does not transact business within the State of Florida. It should also be noted, that this small company's sole shareholder, founder, and president (Burl Woods) suddenly passed away this past January. His wife, Mona H. Woods, is now the President of this small company, and trying to adjust to her new and unwanted position. She just does not need this problem with your office (Florida Department of State) hanging over her with all of her other pressing personal issues, including the current required reorganization of this small business, relating to her husband's untimely and unexpected death. I very much hope that you can appreciate this situation.

Based on the above described facts and circumstances; I, on behalf of the management of this corporation in question respectfully request that the civil penalty and annual report filing fees in the amount of \$3,557.60 relating to this matter be abated. It appears that such was assessed incorrectly when fully viewed based on the company's very limited business activity within the State of Florida based on your organization's definition (actually, none based on my interpretation of your organization's limited definition within the above State of Florida Statues).

Thank you for your assistance and cooperation regarding this request. If I may be of any additional assistance relating to this matter, please do not he sitate to call me.
