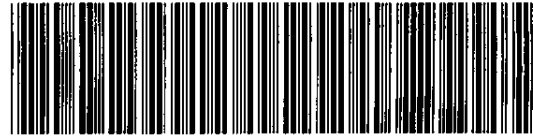



Our Mission

As a child raised on the Southside of Chicago, Juwan Howard has not forgotten the many struggles and challenges he was faced with. It was difficult for him to maintain focused on his hopes and dreams when he was kept awake at night by the sound of gunfire. He remembers how frightened he was walking through the neighborhood streets, which sometimes served as the battleground for teenage gang and drug-related violence. Very early in life Juwan made a commitment to himself that he would never forget how things were during his childhood and he would be committed to do whatever he could to make a difference in the lives of other children living in similar environments. Juwan Howard wanted to establish a vehicle, which could serve as an arm to embrace the many children living with little or no hope for their tomorrows. He wanted to do something to encourage them to never stop dreaming and striving for a brighter future.

Washington Wizards forward, Juwan Howard in February 1994, founded the Juwan Howard Foundation. The Mission of the Foundation is to embrace at risk inner city children living with little hope. The Foundation provides assistance for a better education, expanded recreational opportunities, moral support and encouragement to at-risk children living in the inner cities of Washington, D.C., Maryland, Virginia, Chicago, and Michigan communities.

The Juwan Howard Foundation has been successful in providing over 31,000 articles of warm clothing to area children and adults living in Metropolitan Washington and Chicago, through its *Warm Hearts Drive*. The Foundation has also provided free basketball/educational camps to kids at-risk in Washington, D.C. and Chicago.


