



CERTIFICATE OF AMENDMENT AND RESTATEMENT OF THE ARTICLES OF INCORPORATION OF

THE JEFFERSON COUNTY ASSISTED HOUSING CORPORATION

813-434

WHEREAS, The Jefferson County Assisted Housing Corporation, an Alabama nonprofit corporation (the "Corporation"), was incorporated in Alabama pursuant to Articles of Incorporation filed with the Judge of Probate for Jefferson County, Alabama, in 1980 (the "Original Articles");

WHEREAS, the Corporation has amended the Original Articles five times—twice in 1996, once in 1999, once in 2002, and once in 2011—and filed these amendments with the Judge of Probate for Jefferson County, Alabama (the Original Articles as amended by these amendments, the "Amended Articles");

WHEREAS, the Corporation desires to further amend the Amended Articles to delete Articles VII and VIII and to amend Articles I, II, IV, VI, IX, X, and XI as set forth herein and to restate the Amended Articles as amended by these further amendments, all as set forth herein (the Amended Articles as amended by these further amendments and restated to reflect all amendments to date (including, without limitation, these further amendments), these "Amended and Restated Articles"); and

WHEREAS, these Amended and Restated Articles accurately state the text of the Original Articles as amended by the amendments in 1996, 1999, 2002, and 2011, together with those amendments effected herein, and do not contain any other changes except for information omitted under § 10A-1-3.17(b) of the Alabama Code;

WHEREAS, the Corporation has no members, so no members were entitled to vote on the adoption of these Amended and Restated Articles:

NOW, THEREFORE, the undersigned, being the President and Secretary-Treasurer of the Corporation, do hereby execute and verify on behalf of the Corporation that the Corporation's Board of Directors has made and approved these Amended and Restated Articles (including, without limitation, the amendments to the Amended Articles set forth herein), by the majority vote of the directors then in office at a meeting held on December 5, 2012, all in accordance with, and in the manner required by, Title 10A of the Alabama Code, the Amended Articles, and the Corporation's Bylaws, in each case as amended through the date hereof, to supersede the Original Articles and the Amended Articles, with the amendment herein changing the Corporation's name to take effect on April 1, 2013, and all other amendments and restatements herein to take effect upon the filing of these Amended and Restated Articles, all subject to the approval of the Authority (as defined below) and HUD (as defined below):



AMENDED AND RESTATED ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be NAVIGATE AFFORDABLE HOUSING PARTNERS, INC. (herein the "Corporation").

ARTICLE II. PURPOSES

The purposes for which the Corporation is formed are purely public and charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code, as amended, and the objects to be carried on and promoted by it are as follows:

- (a) To engage in or assist in the development, construction or operation of public housing as an "instrumentality" of the Jefferson County Housing Authority (herein the "Authority") within the meaning of Section 3(b)(6)(A) of the United States Housing Act of 1937, as amended;
- (b) To promote and advance housing projects and related facilities in Jefferson County, Alabama, with the approval of the Authority, for persons who are members of low-income families and very low-income families (including without limitation elderly and handicapped persons), by financing the acquisition, construction and equipping in Jefferson County, Alabama, of one or more buildings and related facilities, all for the use of the Authority;
- (c) To acquire, by lease, purchase or otherwise, land, improvements, rights of way, easements, and other interests in real estate located in Jefferson County, Alabama, as may be necessary or convenient for said housing facilities;
- (d) To borrow money, with the approval of the Authority, in an amount required to pay the costs of acquiring, constructing and equipping such facilities, said debts to be evidenced by securities of the Corporation of any kind or character, issued at any one or more times which may be either unsecured or secured by any mortgage, trust indenture or deed of trust;
- (e) To promote the common good and general welfare of Jefferson County, Alabama, by providing decent, safe and sanitary housing;
- (f) To promote and advance housing projects and related facilities in the State of Alabama and in other states of the United States, with the approval of the Authority, for persons who are members of low-income families and very low-income families (including, without limitation, elderly and handicapped persons), by financing the acquisition, construction and equipping of one or more buildings and related facilities, whether or not located within Jefferson County, Alabama;
- (g) To acquire, by lease, purchase or otherwise, land, improvements, rights-of-way, easements and other interest in real estate whether or not located in Jefferson County, Alabama, as may be necessary or convenient for said housing facilities;

- (h) To serve as the instrumentality and agency of the Authority in the performance of administrative services for the U.S. Department of Housing and Urban Development ("HUD") (including, but not limited to, joint venturing with the Authority, serving as the contract administrator for Project-Based Section 8 Housing Assistance Payment (HAP) Contracts, and assisting such contract administrators in discharging their duties) with such services to be provided throughout the entire States of Alabama, Connecticut, Delaware, Florida, Maryland, Mississippi, New Jersey, North Carolina, Ohio, Rhode Island, and Tennessee, the Commonwealths of Kentucky, Massachusetts, and Virginia, the District of Columbia, and any other State, territory, or possession of the United States of America;
- (i) To provide administrative services for HUD related to the provision of housing for low and moderate income persons including but not limited to serving as the Participating Administrative Entity for HUD in restructuring mortgages; and
- (j) To provide decent, safe and sanitary housing, whether or not located within Jefferson County, Alabama.

ARTICLE III. PERIOD OF EXISTENCE

The duration of the Corporation shall be perpetual.

ARTICLE IV. PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the principal office of the Corporation is 500 Office Park Drive, Suite 300, Birmingham, Alabama 35223, and its registered agent is Eric Strong.

ARTICLE V. MEMBERS

The Corporation is organized on a nonstock basis. There shall be no shareholders or members, and the Corporation shall be deemed to be performing essential public functions.

ARTICLE VI. DIRECTORS

The Corporation shall have a Board of Directors in which all powers of the Corporation shall be vested and which shall consist of three to five (3-5) directors in number, the precise number to be fixed by resolution of the Board of Directors from time to time.

Directors shall be elected annually by the then existing Board of Directors to replace any director or directors whose term or tenure is then expiring. Directors shall have staggered terms of three (3) years ending on December 31 of the year in which such term shall end, or until his earlier resignation, removal from office or death. All vacancies in the Board of Directors shall be filled for the unexpired term in the same manner. No subsequent director elected to fill any vacancy shall be a director until such director is approved in writing by the Authority. No director shall serve past December 31 of the year in which the term ends unless and until reappointed by the Board of Directors and approved in writing by the Authority. If at any time after the election of the initial Board of Directors and for any reason there shall not be any

directors then serving and no successors have been elected, the Authority shall appoint a successor Board of Directors.

ARTICLE VII.

ARTICLE IX. EFFECTIVENESS AND AMENDMENTS

These Amended and Restated Articles of Incorporation shall not be effective unless and until the Authority and HUD shall have approved them. These Amended and Restated Articles of Incorporation may be altered, amended or repealed as provided by law; provided that, any such alteration, amendment or repeal shall be subject to the approval of the Authority and HUD.

ARTICLE X. BYLAWS

The business and conduct of affairs of the Corporation shall be regulated in accordance with Bylaws adopted by the Board of Directors, which Bylaws shall not be inconsistent with these Amended and Restated Articles of Incorporation and which shall only be altered, amended or repealed subject to the approval of the Authority.

ARTICLE XI. PROVISIONS FOR REGULATION AND CONDUCT OF THE AFFAIRS OF THE CORPORATION

No part of the income or profits of the Corporation shall ever inure to the benefit of any member, director or officer except the Authority, or its lawful successors or assigns. The purposes and functions of the Corporation are not to be construed as a delegation of the public governmental functions by the Authority and Jefferson County, Alabama, to this Corporation. The Corporation's purposes shall not be construed so as to circumvent any constitutional or statutory provisions with regard to public financing.

All of the assets of the Corporation shall be held in trust for the purposes herein mentioned, including the payment of all of the Corporation's liabilities. Upon dissolution of the Corporation, all of its assets remaining after the payment of all of its liabilities shall vest in and be transferred to the Authority, or its lawful successor or successors, or failing such succession, to Jefferson County, Alabama, or as a court of law or equity may determine.

Upon its default under any Housing Assistance Payment Contracts or Agreements, if any, into which it may enter with the United States of America, the Corporation must provide for its rights and obligations under said contracts to be assigned to the Authority or such other entity as the United States of America may direct.

Without limiting the generality of the foregoing, this Corporation shall have all the powers, privileges, rights and immunities necessary or convenient for carrying out the purposes for which this Corporation is formed, and the directors hereby claim for this Corporation all the benefits, privileges, rights, and powers created, given, extended or conferred by the provisions of all applicable laws of the State of Alabama pertaining to nonprofit corporations, and any additions or amendments thereto.

Notwithstanding any other provisions of these Amended and Restated Articles of Incorporation, the Corporation shall not conduct or carry on any activities (i) not permitted to be conducted or carried on by an instrumentality of a public housing agency within the meaning of the United States Housing Act of 1937, as amended, and regulations promulgated thereunder, as they now exist or as they may hereafter be amended, (ii) not permitted to be carried on by an organization exempt under Section 501(c)(3) the Internal Revenue Code, as amended, and regulations promulgated thereunder, as they now exist or as they may hereafter be amended, or (iii) not permitted to be carried on by an organization contributions to which are deductible under Section 170(c)(2) of such Code and regulations promulgated thereunder, as they now exist or as they may hereafter be amended.

The Corporation shall not enter into and execute, or alter, amend, or modify, any Performance-Based Annual Contributions Contract, or any other contract or agreement, with HUD unless and until the Authority has authorized such action.
