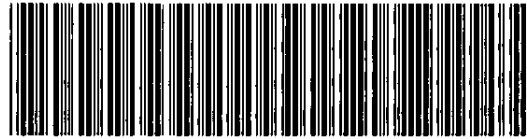

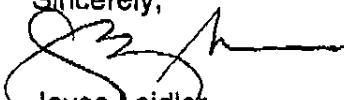
Dear Justin,

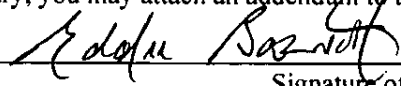
