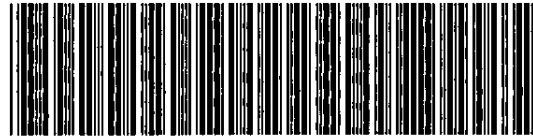

PARAGRAPH 8: PURPOSES: Soldier On, Inc. shall provide housing, treatment services, and counseling for the benefit of homeless veterans in Florida in order to end homelessness among Veterans. Notwithstanding any other provisions of this Application, the organization is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to any corresponding provision of any future Federal tax law, and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) or corresponding provisions of any subsequent tax laws.

No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC 501(h)) or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidates for public office.

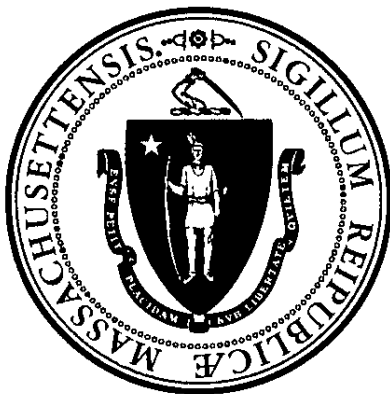
