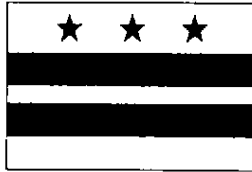

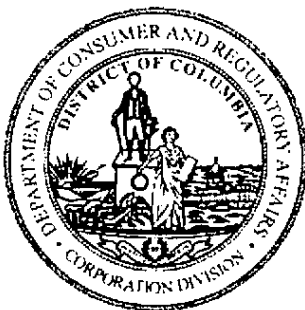

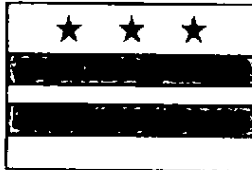

Article First is hereby amended to read, "The name of the Corporation is National Latina Institute for Reproductive Justice."


