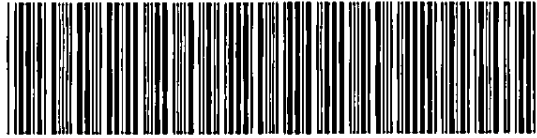

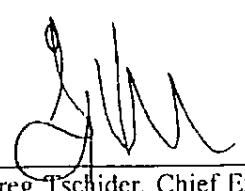
Pursuant to sections 490.1003 and 490.1006 of the Iowa Business Corporation Act, the corporation hereinafter named (the "Corporation") does hereby submit the following Articles of Amendment:

1. The name of the Corporation is Kidder Benefits Consultants, Inc.
2. The Corporation filed Amended and Restated Articles of Incorporation with the Iowa Secretary of State on October 26, 2009 (the "Amended and Restated Articles of Incorporation").
3. Article I of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended and replaced in its entirety to read as follows:
