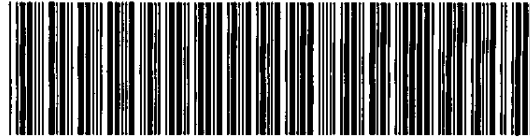

My name is Lilach Chemtob, Esq. I am an Israeli attorney and a NY attorney. I serve as the Israeli general counsel for ROEM HOLDINGS LTD. (an Israeli corporation).

The corporation is now filing an application for authority to transact business in Florida.

The instructions to such filing require that an "original certificate of existence" with a date of not more than 90 days be attached to the application, together with a translation (if the original document is not in English).

This to advise you that, in Israel, there is no equivalent process of obtaining a "good standing certificate" or "certified copy" of the articles of incorporation. Instead, all that is available is a printout from the Corporations' Registrar confirming the status of the corporation as either active, non-active or in violation of the law (for failure to submit annual filings for example).

I am attaching here the printout from the Israeli Corporate Registrar, together with my affirmation of translation confirming that the status of the company as of September 24, 2015 is "active".

I am hopeful that this printout, together with my letter of explanation and the original articles of incorporation from June 25, 2015 will be sufficient to allow the corporation to register to do business in Florida.

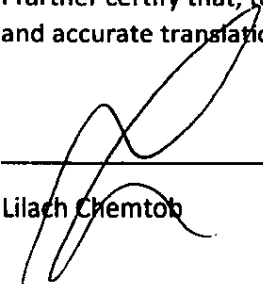
