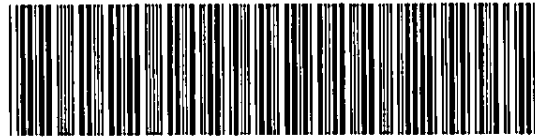



Impact Health Inc., a corporation organized and existing under the General Corporation Law of the State of Delaware, does hereby certify as follows:

**FIRST:** That the name of this corporation is Impact Health Inc.

**SECOND:** The date of filing of the original Certificate of Incorporation of this corporation with the Secretary of State of the State of Delaware was March 1, 2016.

**THIRD:** The Board of Directors of the Corporation, acting in accordance with provisions of Sections 141 and 242 of the General Corporation Law of the State of Delaware (the "DGCL"), adopted resolutions amending its Amended and Restated Certificate of Incorporation as follows:

A. Article First is hereby amended and restated in its entirety to read as follows:

"The name of this corporation is Joany, Inc. (the "Corporation")."
