Our firm, formerly Dungan Nequette Architects had a Florida firm license. Jeffrey Dungan is currently licensed individually as an architect in Florida (see attached paperwork). When the firm split, Nequette Architects kept the tax ID number and we formed a new company (Jeffrey Dungan Architects, Inc.) and received a new tax ID number. We thought we had updated and handled all of the firm and Jeff's licenses in other states since the split but just realized that the Florida Business license (AA26000779) was not. Our online account with FL Department of Business & Professional Regulation pulls up the individual architect license for Jeff as well as an Architect Business License. Jeff for some reason is still listed as the related party. This Business account should be updated to Nequette Architects since I believe it's under their tax ID number. With the individual license being a renewal for Jeff and not a new application, we were never prompted to register the business, which would normally occur with a new individual license and we overlooked the fact that the business also needed to be licensed as well. In turn we need to register the new business, Jeffrey Dungan Architects, Inc. as a foreign profit corporation to transact business in Florida.
