I am returning the documents as requested regarding dissolution of this nonprofit corporation. This corporation was dissolved effective on January 1, 2020. I am the former President of the corporation but I'm acting as its agent and strictly for the purpose of verifying this so that Florida can remove the entity from its record of active corporations.

I enclose the letter I sent to your office previously (dated April 17, 2021). In this letter, I explained that an error occurred when we initially submitted our registration application as a Florida nonprofit corporation. Apparently, Florida registered this entity as a foreign corporation, but it was originally established in Ohio in 2016. In January 2019, the corporation moved its business office to Florida (former address was 6102 Maplewood Dr., New Port Richey, FL 34653). I was not aware until after the corporation had been dissolved that your department listed this entity as a foreign corporation.

In your cover letter dated July 21, 2021, you indicate that the Articles of Dissolution for dissolving a Florida domestic corporation were submitted in error. But because the foreign corporation designation was incorrect, my impression was that your office would be able to correct this designation, process the dissolution and remove The Foundation for the Advancement of the Sign Industry from your record of active corporations. Nevertheless, I have completed the enclosed withdrawal application as per your instructions in the hope that this will accomplish essentially the same result as far as Florida's Department of State is concerned. I previously submitted a check for the dissolution fee (Check #457, dated July 1, 2021) which I assume will now be applied to this withdrawal filing.

As the corporation no longer exists, I cannot take any further action beyond attempting to ensure that Florida is aware this entity is defunct and removes it from your department's official record of active corporations. Please contact me if you have any further questions.
