- 6. On February 28, 2022, the Corporation filed an Amended Annual Report to correct the record and reflect only the true members of the company, namely Todd K. Hinkley, Monica Villavicencio, and Paul J. Talley.
- 7. The 2022 Annual Report filed on February 25, 2022, constitutes a false, fictitious, or fraudulent statement in a matter within the jurisdiction of the Department, as described in Florida Statutes §817.155.
