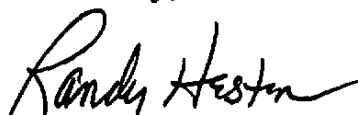
Per my phone conversation with your office, I am enclosing the second notice Corporation Annual Report on my company, P/L Sales Company, along with my check in the amount of \$165.00.
