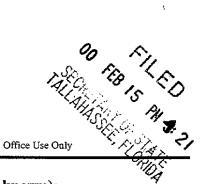

## ARTICLES OF INCORPORATION OF ROCHE SURETY AND CASUALTY COMPANY, INC.

Pursuant to the provisions of Section 607.0704, *Florida Statutes*, Roche Surety and Casualty Company, Inc. ("Corporation") adopts the following Articles of Amendment to its Articles of Incorporation.

**Amendment adopted:** 4. The total number of shares of all classes of capital stock which the Corporation shall have authority to issue is 2,000,000 shares of common stock, par value two dollars and fifty cents (\$2.50) per share.
