

- 1. PLAN OF MERGER

- 1. Southeastern Staffing, Inc. (the "Parent"), which is a business corporation of the State of Florida and is the owner of all of the outstanding shares of (i) Human Resource Management, Inc., a Georgia corporation ("Resource"); (ii) The National Companies, Inc., a Georgia corporation ("National"); and (iii) National Staffing Services of Georgia, Inc., a Georgia corporation ("Staffing" and together with Resource and National, the "Subsidiaries"), hereby merges the Subsidiaries with and into the Parent pursuant to the provisions of the Georgia Business Corporation Code and pursuant to the provisions of the Florida Business Corporation Act.
- 2. The separate existence of the Subsidiaries shall cease at the effective time and date of the merger pursuant to the provisions of the laws of the jurisdiction of its organization; and the Parent shall continue its existence as the surviving corporation pursuant to the provisions of the Florida Business Corporation Act.
- 3. The issued shares of each of the Subsidiaries shall not be converted in any manner, but each said share which is issued immediately prior to the effective time and date of the merger shall be surrendered and extinguished.
- 4. The Board of Directors and the proper officers of each of the Subsidiaries are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
