THE UNDERSIGNED, Timothy L Messett, President of PENSION INVESTORS

CORPORATION OF ORLANDO INCORPORATED, a Florida corporation (the "Corporation"),

for and on behalf of the Corporation, hereby executes these Articles of Amendment to the

Articles of Incorporation of the Corporation:

<u>ARTICLE FIRST</u>: The name of the Corporation is PENSION INVESTORS CORPORATION OF ORLANDO INCORPORATED.

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE III of the current Articles of Incorporation is amended to provide as follows:

## ARTICLE III - AUTHORIZED STOCK

The maximum number of shares of stock of the Corporation that be issued is 50,000 Shares of Class "A" Voting Common Stock having a par value of \$1.00 per share and 50,000 Shares of Class "B" Voting Common Stock having a par value of \$1.00 per share. Each share of Class "A" and Class "B" stock shall be identical in all respects, except that a dividend may be declared and paid by the Corporation to the Class "A" Shareholders without declaring a dividend payable to the Class "B" Shareholders of the Corporation. In addition, if a dividend is declared and paid to the Class "B" Shareholders of the Corporation, a dividend of equal of greater value must be declared and paid to the Corporation's Class "A" Shareholders.

ARTICLE THIRD: The Amendment to the Articles of Incorporation of the Corporation reflected in ARTICLE SECOND hereof was duly adopted by the Shareholders and Board of Directors of the corporation by Joint Unanimous Written Consent, executed on December 21, 1998, in accordance with Sections 607.0704 and 607.0821 of the Florida General Corporation Act.

ARTICLE FOURTH: The effective date of these Articles of Amendment shall be upon the filing thereof with the Florida Department of State.
