

In all the years that we have had the corporation above-referenced, we have never failed to file the Uniform Business Report ("UBR") for this corporation on time, until this year. This is because we were not prompted as usual by receiving the first request for this report that you usually send out at the end of the preceding year and that is normally received by us in January of the year for which the filing is due. For whatever reason, this first notice that you normally send was not received by us in the mail this year as usual, and therefore the corporation did not receive the prior notice.

I saw among the "Frequently Asked Questions" in the form that we received in July one question that specifically addressed this situation wherein the answer stated that the late charge could be waived if the initial form that normally comes out each year was not received and an officer of the corporation attached a letter stating this. As indicated on the enclosed UBR, I am the president of the above-referenced corporation, and I am attaching this letter to state that the prior notice was not received as set forth above, and to request that the late fee be waived owing to this circumstance.



If not, deposit the other check for \$550.00. We would appreciate it if you would return whichever check is not used based on your decision to
