Pursuant to your instructions in our phone conversation on August 11, 2015, I am enclosing an Application By Foreign Profit Corporation To File Amendment To Application For Authorization to Transact Business In Florida (the "Amendment"). As I explained on the phone, my client, Corin USA Limited, was formed as a "Limited Company" under the laws of the United Kingdom. In 1993, my client applied for and was granted authorization to transact business in Florida. Because its official name did not (and does not) comply with Florida statutory requirements, it attached the suffix "Inc." to its name and registered with the State of Florida as "Corin USA Limited, Inc."

The use of "Inc." has caused some public confusion and is currently the subject of much discussion in ongoing litigation involving my client. In an effort to diminish the confusion, my client requests that the suffix "Inc." be replaced with the suffix "Co." in the Division of Corporations' records, thus permitting my client to transact business in Florida under the name "Corin USA Limited, Co.", a designation which more closely represents its true status.

To effect this change, I have enclosed the Amendment form, completed in accordance with your instructions. As we discussed, I have indicated in Item 4 that the name change is <u>not</u> being effected under the laws of United Kingdom. You also stated that the certificate described in Item 8 would not be required. The \$35.00 filing fee is enclosed.
