

Under Section 805 of the Business Corporation Law

CSC 45

FIRST: The name of the corporation is Triak Services, Corp. (the "Corporation").

SECOND: The Certificate of Incorporation of the Corporation was filed with the Department of State on July 17, 1990., under the original name of Thoroughbred Trading, Inc.

THIRD: The amendment of the Certificate of Incorporation effected by this Certificate of Amendment is to effect a name change.
