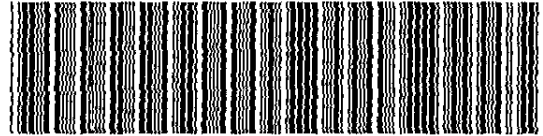

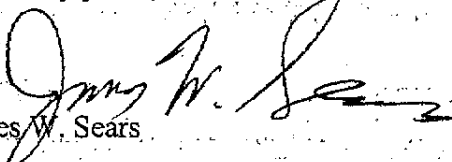

Paragraph 2. The name of the corporation is JAMES W. SEARS, P.A.

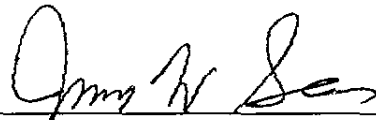
The date of adoption was December 17, 2003.

This amendment shall be effective January 1, 2004.

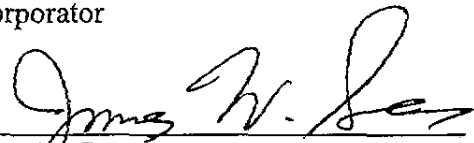
