We have received your correspondence regarding the above referenced corporation, (copy enclosed).


Forum of Delaware was qualified and authorized to do business in Florida upon the filing of qualification documents on June 26, 1995. At this time, the Company retained Corporation Service Company (CSC) located in Tallahassee, Florida as its registered agent in Florida. In retaining a registered agent, the Company believed that it would be notified of any filing requirements by the registered agent as it was and is not familiar with corporate filing requirements in the state of Florida. The Company never received any such notification nor did it receive forms or notification from the Florida Department of Revenue that it was not in compliance with its filing requirements. Additionally, the Company was never notified that its certificate of authority was revoked for failure to file its first corporate annual report (1996). Had any notification been received, the Company would have filed all necessary reports and paid all applicable fees.

When it was discovered that the Company had not filed its corporate annual report for 1998, the report was promptly prepared and filed along with the applicable payment prior to the due date of May 1, 1998. Prior to receiving your notice which was sent in response to the 1998 report, the Company was unaware that it had not been in compliance and that its certificate of authority was revoked.

We therefore, respectfully request that the Company's registration be reinstated and the reinstatement fee of \$600 waived. We thank you for your cooperation in this matter. Please do not hesitate to contact me directly if you have any questions or require additional information.
