On January 12, 1995 the Department contacted the above-noted taxpayer requesting that it either complete and submit an 'Application by a Foreign Corporation for Authorization to Transact Business in Florida', or the 'Statement Concerning Authority to Transact Business in Florida by a Foreign Corporation'.

Subsequent to this communication, the taxpayer did in fact complete and submit the Application for Authorization to Transact Business in Florida indicating therein, in error we believe, that it had been doing business since June 1987.

On March 9, 1995 the taxpayer was contacted indicating that the Department proposed to levy fees and penalties in the amount of \$4,956.25.

We do not believe that the taxpayer is carrying on sufficient business activity to require it to be registered and authorized to do business in the State of Florida. The taxpayer holds a piece of residential real estate on which it receives occasional rental income. In order not to be submit to a flat 30% federal tax on fixed and determinable annual and periodic income, the taxpayer has elected for Federal Income Tax purposes to treat such income as though it is effectively connected with the conduct of a trade or business. Having made this election, the corporation does in fact have taxable income for federal tax purposes and, accordingly, has reported this income to the State of Florida and paid tax thereon when required. In addition, the taxpayer has complied with the State's sales tax laws and collected the requisite tax on any rental income derived.

While there is some degree of activity, we do not believe that this activity is sufficient to constitute the conduct of a trade or business within the State of Florida and, as such, we respectfully request that the imposition of fees and penalties relating to the corporation dating back to 1987 be waived since the corporation is not, in fact, conducting a business in the State of Florida.

We trust that this letter is sufficient in order to have these fees, penalties and interest waived. If you are not in agreement with this, however, would you please contact the writer in order that we can fully understand and explain to our client why such amounts are payable.

Your prompt attention in this regard would be most appreciated.
