


I recently received your letter of 1 April, 1996 stating that the above-referenced corporation was being assessed a fine of \$1,000.00 based on transacting business in Florida prior to qualification. This arose out of the application provided to your offices at the end of March which stated that the company began transacting business in Florida on the date of incorporation, 13 February, 1996. This information is incorrect. The only business to be transacted in Florida is the operation of rental real estate in Broward County. Currently the property is deeded in the name of David R. Frye, the principal of the corporation and has been in his name as an individual from the time Mr. Frye took control of the property. Mr. Frye incorporated under the aforementioned name in Georgia on 13 February, 1995 for purposes of maintaining rental real estate in the Atlanta area and to conduct his design-business here. Please accept the enclosed deed for the Broward County property as evidence that the title to the property has not been changed into the company's name.

The mistake occurred because Mr. Frye anticipated immediately registering his corporation in Florida and filled out the application accordingly. However, personal problems and additional work load caused him to put off filing the application and transferring the title to the property in Florida until now. The application was simply never altered to account for the time delay in filing. If this letter is insufficient to alter your decision on this matter, we can certainly provide an affidavit of Mr. Frye restating these facts. Please proceed with the filing of the application to do business in Florida with this letter as an addendum to that application. If you have any further questions, please feel free to contact me.

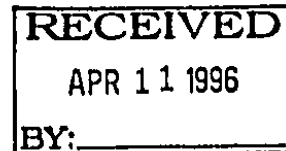
