

- 5. The total number of shares of stock which the corporation shall have the authority to issue is Two Hundred Fifty Thousand (250,000) and the par value of each such share is Twenty Dollars (\$20.00), amounting in the aggregate to Five Million Dollars (\$5,000,000).
- 6. The term for which this Corporation shall exist shall be perpetual.
- 7. In furtherance and not in limitation of the powers conferred by statute, the board of directors is expressly authorized to make, alter and repeal the by-laws of the corporation.  $\chi_{\rm SF}$
- 8. Elections of directors need not be by written ballot unless the by-laws of the corporation shall so provide.

Meetings of stockholders may be held within or without the Commonwealth of Pennsylvania, as the by-laws may provide. The books of the corporation may be kept (subject to any provision contained in the statutes) outside the Commonwealth of Pennsylvania at such place or places as may be designated from time to time by the board of directors or in the by-laws of the corporation.
