I have received our Application By Foreign Corporation For Authorization To Transact Business in Florida form and I have inserted our Federal I.D. number, which I inadvertently left out.

In further reviewing our files, I found that we did business in Florida in 1992 only, not "since 1994" as I previously stated. Our intent is to attempt to start doing business in your State. I believe in section 607.1501-607.1532 that we fall under the 607.1501 section F because we solicit or obtain orders by phone. To give you an outline of what our company does, we are an entertainment agency. Our business in 1992 was with the Florida State Fair, attempting to find entertainment for their grandstand; which is now inside their building. We found entertainment, by phone, to perform at the Fair, most of those acts were out of Nashville. Our fee was extremely low in 1992 in hopes that we would be able to do future years, but as I am sure you are aware, things have not gone very well at the Fair since that time period.

Our intent is to try to work with the Florida Department of Agriculture and start doing business at the Florida State Fair again in the future. I really want to do things properly and that is why I have attempted to file this information. We do business in a great many States, some of which you need authorization and some have a reciprocal agreement with the State of Kentucky. I am in hopes we did not go against any laws in 1992, I assure you there has been no business transacted since that time nor prior to that time.
