
Dear Mr. Heckmann:


This letter is in reference to yours of January 30, 1996, letter number 496A00004103.



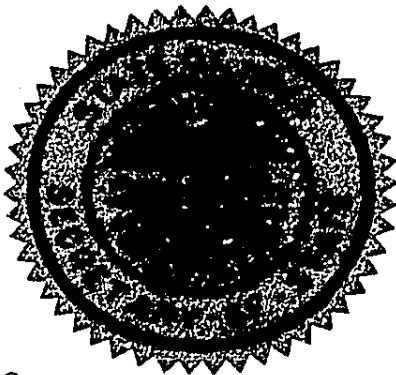
