This letter is in response to your letter (copy attached) to The Student Conservation Association, Inc. ("the Association") dated May 17, 1996; Letter Number: 096A00024603; Reference Number: W96000010533.

I hereby swear that the information regarding the Association's initial date of transacting business in the state of Florida, as indicated in the qualification application is erroneous. The correct date of transacting business in the state of Florida has not yet occurred. Upon qualification we intend to transact business, as defined by Florida, with the Florida State Parks Department, specifically Jonathan Dickinson State Park.

For the record, the conclusion that we have not transacted business in Florida was reached after consultation with our legal counsel. Our confusion had to do with our primary service as a not-for-profit organization of placing volunteers with federal agencies, on federal lands. We have never maintained a presence, or contracted with any party doing business in the state, the date indicated reflects our placing of volunteers on behalf of federal agencies on federal lands in Florida.

I thank you for contacting me regarding the potential error in our application and thank you for your prompt notice and help on the telephone.

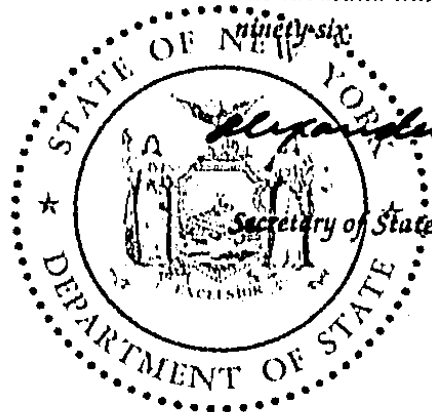
