
Thank you for the last letter (number 396A00044760) explaining what is needed for our church to complete its incorporation process. We hope this new letter has the necessary corrections.

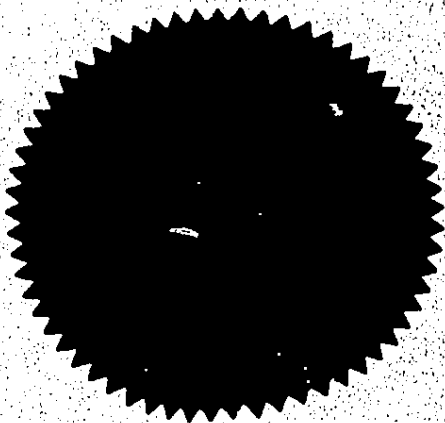
