**Important Business News from the Florida Department of State's  
Division of Corporations:**

- **Uniform Business Report Replaces Annual Report**
- **Internet Filing Available**
- **Business Trade Survey**

Dear Business Owner:

The Department of State's Division of Corporations is now offering the ability to file the Uniform Business Report (UBR) for profit and non-profit corporations, limited partnerships, and limited liability companies on the internet. This process should save you both time and money, while helping to make statewide records as accessible and up-to-date as possible.

The internet UBR requires that you utilize your business entity Document Number found in Block 1 of the UBR, and the Electronic Access Code Number found in the lower right hand corner of this page. The UBR file date will be the date that the UBR is correctly filled out and transmitted online to the Division of Corporations. The UBR filing fee can either be deducted from a Sunbiz E-Filing Account or charged to a "Discover" credit card. If the E-Filing Account has sufficient money deposited to cover the UBR filing fee, the report will be accepted for processing immediately. If a "Discover" credit card is used, the UBR will be reflected on the database within 24 hours of processing and verification of fees. We are working towards expanding the number of credit card companies that are willing to participate in this process. Please check our website for updates.

The Division is also now offering the opportunity for registered entities to submit trade information with the prospect of enhancing their business activity. This data will be made available on the internet to assist trade interests outside the State of Florida in locating business partners within the state. The information can be submitted online utilizing the Document Number and Electronic Access Code to complete the Business Trade Survey.

Go to the Division's "SUNBIZ" page at [www.sunbiz.org](http://www.sunbiz.org), click on Electronic Filing, and select either the Uniform Business Report or the Business Trade Survey. If you elect to complete the Uniform Business Report, you will automatically be prompted to complete the Business Trade Survey.
