On behalf of General Commercial Corporation I am requesting that you waive the \$400.00 late filing fee for the 1998 Annual Report of Corporations for this our first year of filing with the State of Florida. Per discussion with a service representative at the Department of State, she suggested that I submit my request to your attention along with the annual report of corporations.

Late in 1997, our company began doing business in Florida by having an Ohio sales representative covering that territory.
