1. Affiant Information

I, Andrew P.C. Wright, hereby certify that I am a duly elected and qualified Vice President and Corporate Secretary of MARRIOTT INTERNATIONAL, INC. ("MII"), and in such capacity, have access to its corporate records, and the statements herein are based on my personal knowledge.

On February 4, 2025, an annual report filing for MII was submitted to the Florida Department of State, Division of Corporations ("FDOS") by an unauthorized individual, Robert Pietz, whereby he appointed himself as "Chief Legal Counsel" for MII and signed the annual report as an officer with the title of "Lead Janitor".

4. Statement of Non-Consent

MII did not authorize, consent to, or have any knowledge of this change. It was made without MII's approval, and it is fraudulent. Once MII was made aware of the unauthorized fraudulent filing on May 6, 2025, an amended annual report was filed immediately to remove Robert Pietz.

MII acknowledges that the FDOS acts in an administrative filing capacity only and does not have statutory authority to regulate individual businesses nor does it have investigative capability.
