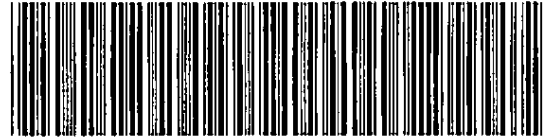

Pursuant to the provisions of Section 242 of the General Corporation Law of the State of Delaware, ION Television Net, Inc., a Delaware corporation (hereinafter, the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: The name of the Corporation is ION Television Net, Inc.

SECOND: The Corporation was originally incorporated on September 19, 1997.

THIRD: The Certificate of Incorporation of the Corporation is hereby amended by deleting in its entirety Article I of the Certificate of Incorporation and substituting it to read as follows:

"ARTICLE I

The name of this corporation is ION Media Networks Distribution, Inc."

FOURTH: That the foregoing Certificate of Amendment to the Certificate of Incorporation of the Corporation was approved by the Board of Directors and the sole stockholder of the requisite number of shares of the Corporation in accordance with Section 141(f) and Section 228 of the General Corporation Law of the State of Delaware, as amended.
