In response to the above referenced letter and related APPLICATION BY FOREIGN CORPORATION FOR AUTHORIZATION TO TRANSACT BUSINESS (copies attached), we would like to provide the following clarification. Arning Industries, Inc., in an effort to properly register to conduct business in the state of Florida, indicated the date they first transacted business in Florida on their application as December 11, 1995. The business conducted on that date was an isolated transaction to perform minor fascia repair work that took approximately 2 days to complete.
