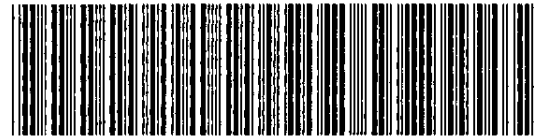

**ARTICLES OF AMENDMENT
OF

CHANGING ITS NAME TO
GWWO, Inc.**

Grievess, Worrall, Wright & O'Hatnick, Inc., a Maryland corporation, having its principal office at 800 Wyman Park Drive, Suite 300, Baltimore, Maryland 21211 (hereinafter called the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Charter of the Corporation is hereby amended by striking in its entirety Article Second and by substituting in lieu thereof the following:

SECOND: The name of the Corporation (which is hereinafter called the "Corporation") is GWWO, Inc. ✓
