I am writing in reference to your correspondence to CT Corporation System concerning Vastera, Inc.'s qualification in the State of Florida. Enclosed is a copy of that correspondence for your convenience. In short, you have indicated that Vastera, Inc. is being assessed penalties in the amount of \$8,265 for transacting business in Florida prior to qualification. I am writing to formally request a waiver of penalty.

Vastera, Inc. has entered into a voluntary disclosure agreement for Florida sales/use and corporate income taxes – DTA #9900214, which was filed with Ms. Kathleen Marsh with the State of Florida Department of Revenue on June 4, 1999. As part of that agreement, the State of Florida agreed not to assess any penalties of any kind for sales/use tax and income tax for the periods prior to February 1, 1999. In addition, Vastera, Inc. agreed to promptly register and comply with all future filing requirements.

Vastera, Inc. was not aware of the requirements to file for qualification for the following reasons:

- Vastera's failure to comply resulted from unintentional oversight and lack of sophistication regarding Florida's laws and not from negligence or intentional disregard.
- Vastera had qualified in the Commonwealth of Virginia (where the corporation is headquartered).
- Vastera does not own or lease an office in Florida.
- Vastera does not have property in Florida.
- Vastera has no employees residing or located in Florida.
- Vastera believed it had minimal activity, and therefore nexus had not been established in Florida.
