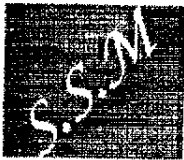


As the existing Charity Commissioner was changed, the new Commissioner Mr. Michael Lendor did not treat this as very urgent and hence the delay.

Thank you for your letter dated 5th May and enclosures.

As you are aware the charity is governed by constitution adopted 13th August 1996. The charity's objects are as follows:

- The relief of poverty, sickness, and distress amongst South-east Asian ethnic minorities living primarily but not exclusively in the United Kingdom and to provide facilities in the interests of social welfare for recreation and other leisure time occupation with the object of improving the condition of their lives;
- To provide language training, information, training for employment, and advice to people of south-east Asian origin; and
- To develop community awareness of the culture, needs, and rights of women from Southeast Asian minorities.

Notwithstanding the object to develop community awareness of the rights of women from south-east Asian minorities, the beneficiaries of the charity are not restricted to women only. Therefore to amend the existing name to Subhag Stree Mandal International Women's Organisation would be rather misleading in view of the primary purposes of the charity. Therefore we are unable to agree to the proposed change of name.

I enclose a print-out of the charity's details taken from our database, which you can pass on to Florida Department of State. The print-out is confirmation that the charity is registered in England and Wales.


I note your proposal to change the name of the charity to Subhag Stree Mandal International

As you know the change of name requires an amendment to the constitution. The constitution may be altered by a resolution passed by not less than two-thirds of the members present and voting at a general meeting.
