I.

#### PREAMBLE

- 1.1 The Target Banks and SunTrust Bank, Atlanta are all indirect wholly owned subsidiaries of SunTrust Banks, Inc.
- 1.2 The merger of banks across state lines and the maintenance of interstate branches following the merger is authorized by Section 102 of the Riegle-Neal Interstate Banking and Branching Efficiency Act of 1994, Section 7-1-628.2 of the Official Code of Georgia Annotated and Section 658.2953 of the Florida Statutes. The intrastate merger of banks located within Georgia is authorized by Section 7-1-550 of the Official Code of Georgia Annotated.
- 1.3 SunTrust Banks, Inc. and each of the Target Banks and SunTrust Bank, Atlanta desire to take advantage of the efficiencies inherent in eliminating separate bank charters and operating one bank with interstate branches.

#### THE MERGER

#### 2.1 Merger

Subject to the terms and conditions of this Plan, at the Effective Time (as defined below), the Target Banks shall be merged with and into SunTrust Bank, Atlanta as authorized by Section 7-1-530 of the Financial Institutions Code of Georgia and in accordance with the provisions of Sections 7-1-531, 7-1-532, and 7-1-533 of the Financial Institutions Code of Georgia. SunTrust Bank, Atlanta shall be the surviving bank resulting from the mergers. At the Effective Time, the separate existence of the Target Banks shall cease. The Mergers shall be consummated pursuant to the terms of this Plan.

#### 2.2 Effective Time

The Effective Time of the Mergers shall be as specified in the Articles of Merger.

### 2.3 Articles, Bylaws and Name

- (a) The Articles of Incorporation of the Surviving Bank shall be the Articles of Incorporation of SunTrust Bank, Atlanta in effect immediately prior to the Effective Time, except the name of the Surviving Bank shall be changed to "SunTrust Bank."
- (b) The Bylaws of SunTrust Bank, Atlanta in effect immediately prior to the Effective Time shall be the Bylaws of the Surviving Bank from and after the Effective Time until otherwise amended or repealed.
- (c) The name of the Surviving Bank shall be "SunTrust Bank".

#### 2.4 Directors and Officers

The Directors and Senior Officers of the Surviving Bank at the Effective Time of the Mergers and until their successors have been elected or appointed and qualified shall be as listed on Exhibit A, attached hereto. All officers of SunTrust Bank, Atlanta and the Target Banks with the rank below Senior Vice President who are in office immediately prior to the Effective Time, together with such additional persons as may thereafter be appointed, shall continue to serve as officers of the Surviving Bank from and after the Effective Time in accordance with the Bylaws of the Surviving Bank.

#### 2.5 **Offices**

The principal office of the Surviving Bank will be located at One Park Place, N.E., Atlanta, Georgia 30303. Immediately after the Effective Time, all branches of the Target Banks shall become branches of the Surviving Bank.

- Existence, Rights, Franchises, Duties, Assets and Liabilities of the Surviving 2.6 Bank.
- As of the Effective Time, the corporate existence of the Target Banks shall be (a) merged into and continued in the Surviving Bank, and the Surviving Bank shall be deemed to be the same institution as the Target Banks and SunTrust Bank, Atlanta.
- As of the Effective Time, all rights, franchises and interests of both the Target (b) Banks and SunTrust Bank, Atlanta in and to every type of property (real, personal and mixed) and all chooses in action of both the Target Banks and SunTrust Bank, Atlanta shall be transferred to and vested in the Surviving Bank without any deed or other transfer. The Surviving Bank, upon consummation of the mergers, and without any order or other action on the part of any court or otherwise, shall hold and enjoy all rights of property, franchises and interests, including appointments, designations and nominations, and all other rights and interests as trustee, executor, administrator, registrar of stocks and bonds, guardian of estates, assignee, receiver and committee of estates of incompetent persons and in every other fiduciary capacity, in the same manner and to the same extent as such rights, franchises and interests were held or enjoyed by either the Target Banks or SunTrust Bank, Atlanta at the Effective Time.
- All liabilities and obligations of both the Target Banks and SunTrust Bank, (c) Atlanta of every kind and description shall be assumed by the Surviving Bank, and the Surviving Bank shall be bound thereby in the same manner and to the same extent that the Target Banks and SunTrust Bank, Atlanta were so bound at the Effective Time.

## MANNER AND BASIS OF CONVERTING SHARES OF STOCK

- All of the shares of SunTrust Bank, Atlanta issued and outstanding at the Effective Time shall remain issued and outstanding after the Effective Time and shall be unaffected by the Mergers.
- Each share of the common stock of the Target Banks issued and outstanding at 3.2 the Effective Time shall be cancelled, without any action on the part of the holders thereof.

### **APPROVALS**

### 4.1 Shareholders

The sole shareholder of each of the Target Banks and SunTrust Bank, Atlanta shall approve the Mergers prior to consummation of the Mergers.

### 4.2 Regulatory Approvals

The transactions contemplated by this Plan may not be consummated unless (a) the Georgia Department of Banking and Finance shall have approved the Mergers and shall have issued all other necessary authorizations and approvals for the Mergers; (b) the Board of Governors of the Federal Reserve System, acting either directly or through delegated authority, and any other appropriate federal regulatory agency shall have approved the Mergers and shall have issued all other necessary authorizations and approvals for the Mergers, and any statutory waiting period shall have expired; and (c) the applicable state banking Departments shall have been notified of the Mergers and shall have received all required information.

V.

### TERMINATION AND AMENDMENT

#### 5.1 Termination

This Plan may be terminated by the consent of all of the Target Banks and SunTrust Bank, Atlanta at any time prior to the Effective Time; provided, however, that any Target Bank may withdraw from this Plan by the unilateral action of a majority of the directors of such Target Bank and this Plan shall thereafter be terminated only with respect to that Target Bank, but shall continue in full force and effect with respect to all other Target Banks and SunTrust Bank, Atlanta.

### 5.2 <u>Amendments</u>

To the extent permitted by law, this Plan may be amended by a subsequent writing signed by each of the Target Banks and SunTrust Bank, Atlanta.
