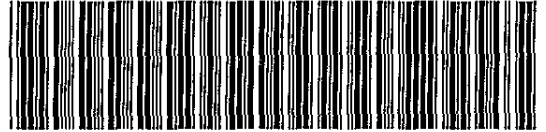

**ARTICLES OF RESTATEMENT  
OF  
THE RAFFENSPERGER CORPORATION**

Pursuant to O.C.G.A. § 14-2-1007 of the Georgia Business Corporation Code, THE RAFFENSPERGER CORPORATION, a Georgia corporation, hereby submits the following Articles of Restatement:

1.

The name of the corporation is THE RAFFENSPERGER CORPORATION (the "Corporation"); the original date of incorporation was January 2, 1985 and the charter number of the Corporation is J500188.

2.

The Articles of Incorporation are hereby amended to change the name of the Corporation to TRILLIUM STRUCTURES, INC.

3.

The corporation shall have authority to issue not more than 100,000 shares of no par value stock.

4.

The current registered office of the corporation is at 1255 Buford Highway, Suite 201, Suwanee, ~~Fulton~~ County, Georgia 30024. The current registered agent of the corporation at such address is BRADFORD J. RAFFENSPERGER.

No director shall be liable to the corporation or its shareholders for monetary damages for any action taken, or any failure to take any action, as a director, except liability:

- a. For any appropriation, in violation of his or her duties, of any business opportunity of the corporation;
- b. For acts or omissions which involve intentional misconduct or a knowing violation of law;
- c. For the types of liabilities set forth in O.C.G.A. § 14-2-832; or
- d. For any transaction from which the director received an improper personal benefit,

provided, however, that the within article shall not eliminate or limit the liability of a director for any act or omission occurring prior to the date hereof.

7.

In discharging the duties of their respective positions and in determining what is believed to be in the best interests of the corporation, the board of directors, committees of the board of directors, and individual directors, in addition to considering the effects of any action on the corporation or its shareholders, may consider the interests of the employees, customers, suppliers, and creditors of the corporation and its subsidiaries, the communities in which offices or other establishments of the corporation and its subsidiaries are located, and all other factors such directors consider pertinent. It is provided, however, that the within article shall be deemed solely to grant discretionary authority to the directors and shall not be deemed to provide to any constituency any right to be considered.

8.

The filing of the within Articles of Restatement was duly adopted by the Board of Directors by resolution dated August 5, 2004, in accordance with O.C.G.A. § 14-2-1007 of the Georgia Business Corporation Code.

9.

The filing of the within Articles of Restatement was duly approved by the shareholders in accordance with O.C.G.A. § 14-2-1003 of the Georgia Business Corporation Code.

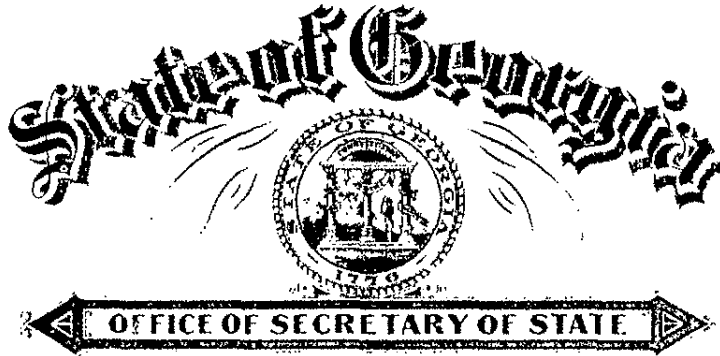
