Enclosed herewith please find a Reinstatement Form for the above-referenced corporation, together with a check in the sum of \$150.00, payable to the Secretary of State, representing the annual filing fee for the year 2000.

WE ARE AWARE THAT THE STATE HAS ASSESSED A FEE OF \$900.00 TO REINSTATE THIS CORPORATION, HOWEVER, PLEASE CONSIDER THE FOLLOWING:

In April, 1999, the Annual Report was filed together with the required payment. The State kept the payment (copy of canceled check is enclosed) but sent the Annual Report back, apparently because I, as the new registered agent, did not sign it.

Unfortunately, the Annual Report was sent to the principal office of the corporation, but my clients, who are foreign nationals, were out of the country and never received the report. When they recently returned, we learned that the Annual Report for 2000 was never sent because the corporation had been dissolved.

If the State needed my signature, they should have sent the report to me. Also, if the State had not cashed the check, we would have learned much sooner that there was a problem and could have rectified it in 1999. Instead, when our check was cashed, we understood that to mean that the 1999 Annual Report was filed.
