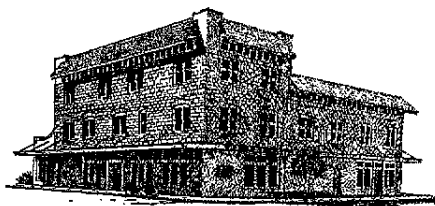

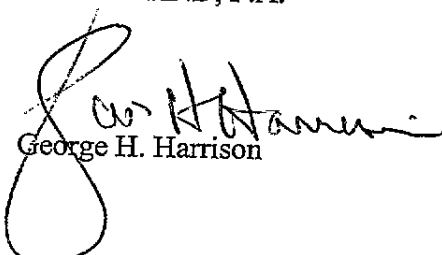

AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

CONARD RTC CORP.

The undersigned President and Vice President/Secretary of CONARD RTC CORP. corporation organized under the laws of the State of Florida, hereby certify:

1. That the name of the corporation is CONARD RTC CORP.
2. The Articles of Incorporation of said corporation are hereby amended by deleting all words and figures contained in ARTICLE IV - CAPITAL STOCK and inserting the following in the place and stead thereof:

"ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the Corporation shall be one hundred (100) shares of Series 1 common stock with full voting rights having no par value and nine thousand nine hundred (9,900) shares of Series 2 nonvoting common stock having no par value. The only limitation existing on the Series 2 common stock shall be the absence of voting rights. Both issues of common stock of the Corporation shall, together, be entitled to receive the net assets of the Corporation upon dissolution."

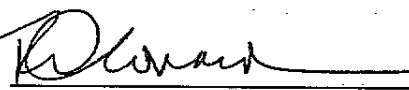
3. In all other respects the Articles of Incorporation are ratified, reaffirmed and remain unchanged.

4. The above Amendment to the Articles of Incorporation of CONARD RTC CORP. was adopted by Unanimous Written Consent of the Board of Directors and Shareholders of CONARD RTC CORP. on the 22nd day of January, 1998.

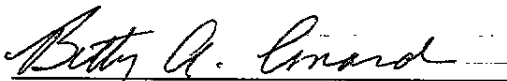

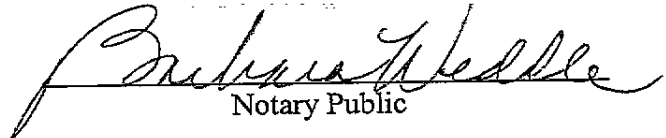
