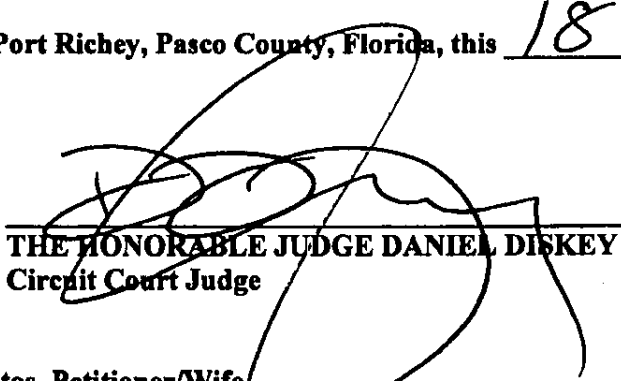
approved and incorporated into this judgment by reference and the parties are hereby ordered to comply with all executory provisions thereof.
