I am writing with regard to payment of my 2002 UBR.

I recently received a form indicating the deadline for filing was September 12, 2002, and that the fee was \$550. It referred to a previous mailing indicating a May first deadline and a fee of \$150. I scoured my records and show no such notice was received.

After eleven years at my own address, I recently relocated into someone else's facility.
