The undersigned, being the President and Secretary of CRAMER BROTHERS LAWN SERVICE, INC., hereby certify that:

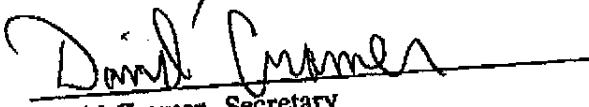
1. The name of the Corporation is CRAMER BROTHERS LAWN SERVICE, INC.
2. The manner in which this Amendment to the Articles of Incorporation was authorized, was by the Unanimous Written Consent of the Board of Directors of the Corporation, effective May 14, 1999, followed by the Written Consent of the holders of all of the issued and outstanding shares of the Corporation, effective May 14, 1999.
