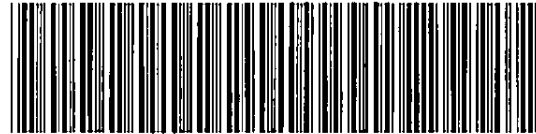

ARTICLES OF INCORPORATION

OF

FLORIDA

INCORPORATED

I, the undersigned, a natural person of the age of 21 years or more, acting as incorporator of a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is Gator Gypsum, Inc.

ARTICLE TWO

The period of duration of the corporation is perpetual.

ARTICLE THREE

The corporation is formed for the following purposes:

- (1) To sell and distribute drywall and related products, and
- (2) To engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.
