ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF AETNA U.S. HEALTHCARE, INC.

Pursuant to Section 607.1006 (1) of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Aetna U.S. Healthcare, Inc.
- 2. The original Articles of Incorporation of the Corporation was filed with the Secretary of State of the State of Florida on June 4, 1984.
- 3. The Articles of Incorporation of the Corporation are hereby amended to change the name of the Corporation from Aetna U.S. Healthcare, Inc. to Aetna Health Inc. by deleting the Article I of Articles of Incorporation of the Corporation in its entirety and inserting the following in lieu thereof:

Article I

The name of the corporation is Aetna Health Inc.

- 4. This Amendment was authorized and approved by the Board of Directors of the Corporation by vote and was duly adopted in accordance with the provisions of the Florida General Corporation Act.
- 5. This Amendment was authorized and approved by the sole shareholder of the Corporation by unanimous written consent and was duly adopted in accordance with the provisions of the Florida General Corporation Act as of February 23, 2001.
