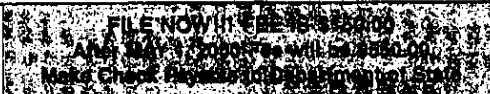

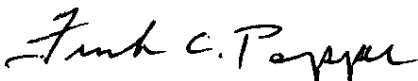
I have done all these things per the above instructions, as evidenced by the revised enclosed filing statement in which my 2000 filing statement has been updated to reflect current data for the year 2001.
