
Dear Shawn,

I am writing to request reinstatement of my corporation and demanding waiver of the reinstatement fee. In September of 1994 I bought a building and moved the location of my business. On the Annual Report for 1995 I indicated an address change. In a conversation with Leslie Sellers she said that I failed to mark the change of address for the mailing address. By reviewing the attached document you can clearly see that both the Principal Place of Business and Mailing Address section has been changed to reflect the new address.

This has been a tremendous inconvenience for me. Not only have I been without the protections that a corporation provides me, it has seriously delayed a refinancing of my commercial property and has cost me by delaying this. What is the state going to do for me from a service standpoint for this obvious failure to do what should have been done.

Ms. Sellers also stated that three notices were sent to the old address. Wouldn't it make sense that where an address change is involved to send notices to both addresses especially if you have gotten no response from the first two inquiries. But that would be way too sensible.

As you may be able to tell I am particularly upset by this circumstance and therefore expect immediate attention to this matter.
