#### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GROSSMAN AND ROTH, P.A.

- 1. The name of the corporation is GROSSMAN AND ROTH, P.A. (the "Corporation").
- 2. The date of filing of the Articles of Incorporation of the Corporation with the Secretary of State of the State of Florida was July 15, 1985, under Document Number H66307.
- 3. These Articles of Amendment to Articles of Corporation have been duly authorized and directed by Written Consent of the Shareholders Entitled to Vote of the Corporation dated March 21, 2006 and the number of votes cast for the amendment was sufficient for approval.
- 4. The Articles of Incorporation of the Corporation are hereby amended by the restatement of Article I as follows:
